I, Rima Mohamed Attar, Petitioner in this matter, affirms the following to be true under penalties of perjury pursuant to Section 2106 of the CPLR:

1. The aforementioned allegations were never previously litigated. In attempts to resolve these issues, I was repeatedly advised at length to settle this matter. Again, these incidents were never litigated.
2. The allegations made were grave offenses in nature. The Respondent continuously utilizes the stipulation of settlement for his egregious behavior.

3. The prior inquiries made regarding the child's whereabouts and inquiries about why the child was at a specific location when not previously told about that specific location, were not a one-time occurrence as the Respondent attempts to disguise it. In fact, it was a repeated occurrence, leading the Petitioner to believe that her vehicle was tagged with a tracking technology.
4. The Respondent made numerous social media posts with threats, and disparaging comments about me.
5. The Respondent continues to make disparaging comments about me to our daughter who continues to exhibit traumatized behavior as a result of these incidents, more specifically, the most recent incident on March of 2025.
6. The very fact that this incident occurred 4 years after I left the marriage, and in front of our child, indicates the very need for this Order of Protection.
7. I do not feel safe without this Order of Protection. It is clear from his motion that the Respondent feels that his behavior is justified and should be without consequences, which based on prior experience of settling this matter, will lead to another incident.

WHEREFORE, Petitioner respectfully requests that the Respondent's application be denied in full.

I affirm this 29th day of September, 2025, under the penalties of perjury under the laws of New York, which may include a fine or imprisonment, that the foregoing is true, and I understand that this document may be filed in an action or proceeding in a court of law.
